NEW ARTISTS

- Submit photos of their work, including a booth shot if available. You may include printed photos with the application or digital images via email to glenparkartfestival@gmail.com.

ALL ARTISTS

- The ARTIST must have direct hands-on involvement in the creation and execution of each piece of work. **NO** commercially made items are allowed to be sold at the show and all reproductions must be clearly and individually labeled as such.
- Acceptance into the show is at the discretion of the Glen Park Art Festival Committee. Notification of acceptance will be by April 30, 2019.
- Artists must provide their own tent and are responsible for the set up of such. Spaces are 12 feet wide and 10 feet deep. Tents must be weighted down. Set up is Friday afternoon.
- The artist is responsible for their own work and they or their representative **MUST BE PRESENT** at all times during the 2-day festival.
- Booths **MUST** remain open from 10:00am – 5:00pm on Saturday and 10:00am-5:00pm on Sunday.
- Artists may share a booth. Each artist must submit the NON-REFUNDABLE \$25.00 APPLICATION FEE and NOTARIZED HOLD HARMLESS AGREEMENT. If accepted, they may show their collaborative/individual displays. Booth fee of \$115.00 may be shared.
- A limited number of double booths are available for a \$230 fee.

The Glen Park Art Festival, Village of Williamsville, and participating organizations are not responsible for the artist's work at this show. Artists should insure their own work.
