

NOTICE TO BIDDERS

CONTRACT NO. 43 2021 MILLING AND PAVING VARIOUS VILLAGE ROADS

VILLAGE OF WILLIAMSVILLE, ERIE COUNTY, NEW YORK

Sealed bids for Contract No. 43 - 2021 Milling and Paving – Various Village Roads in the Village of Williamsville will be received by the Village Clerk at her office located in Village Hall, 5565 Main Street, Williamsville, New York 14221 on or before 10:00 A.M. local time on the 19th day of August, 2021, at which time they will be publicly opened and read aloud.

The project consists of furnishing labor, material, and equipment necessary to perform cold milling, brooming and cleaning milled roads, tack-coat application, Type 7F top course overlay, maintenance and protection of traffic, joint filling where necessary, replacement of pavement markings, ADA accessible curb ramps and associated concrete sidewalk and curbing along various Village roads.

Beginning at 9:00 a.m. local time, on Monday, August 2, 2021, if bidders wish to purchase printed copies of the Contract Documents, they must be obtained through Avalon. The fee paid to Avalon is non-refundable. **Only official planholders will be allowed to bid on the project.** Bidders acknowledge that they are responsible for review of all components of the Contract Documents, including all specification sections and drawings, regardless of how many drawings they print and in which format/size they are printed.

Each bid proposal shall be submitted in a sealed envelope, clearly marked “BID ENCLOSED – CONTRACT NO. 43; 2021 MILLING AND PAVING - VARIOUS VILLAGE ROADS”.

Each proposal must be accompanied by a certified check, payable to the Village of Williamsville, for a sum equal to five per centum (5%) of the total amount of the Bid, or a bid bond with sufficient sureties in a penal sum equal to five per centum (5%) of such total bid amount, conditioned that if the proposal is accepted, that he/she will execute within fifteen (15) days from the date of the acceptance of the proposal, a suitable security bond in the amount of the Contract, conditioned for the faithful and prompt performance and completion of the Work specified in the Contract. All bid deposits except that of the successful bidder will be returned. This is a prevailing wage rate project.

The Village reserves the right to reject any and all bids, to consider the reputation and experience of any bidders in making its selection, to waive any informalities or minor deviations from the specifications, and to award the contract to other than the lowest bidder, if considered to be in the best interest of the Village of Williamsville.
