Additional Information:

- 1. Front Yard Setback: accessory buildings are not permitted in front yard.
- 2. Side Yard Setback: accessory buildings are not permitted in side yard.
- 3. Rear Yard Setback: no part of an accessory building shall be closer than 2 feet to a lot line.
- 4. In the case of a corner lot, no accessory building or structure shall be closer than 10 feet to a rear lot line, nor shall it be closer to the exterior side lot line than an average of existing buildings within 150 feet on either side.
- 5. The maximum height of an accessory building or structure is 14 feet.
- 6. In no case shall any part of an accessory building be located within 10 feet of any other building or structure unless the accessory building is constructed with materials that will afford one hour of fire protection, in accordance with the New York State Uniform Building and Fire Safety Code. In no event, however, shall the distance between buildings and structures be less than 8 feet.
- 7. Survey submitted with application must show all buildings, septic, grinder, easements, and setbacks. The location of the proposed structure must be clearly indicated, and distances from the proposed structure to property lines and proximate structures must be shown.
- 8. Per section 403 of the 2015 Uniform Residential Code, all freestanding structures in excess of 600 sq. ft. and/or over 10 ft. tall at the eave must meet frost protection requirements. Plans for all freestanding structures in excess of 600 sq. ft. must bear the stamp of a design professional.
- 9. If the proposed structure incorporates trusses, a stamped truss certificate must be submitted with the application.
