This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby close that portion of the highway in the Village of Williamsville, said County, known as Erie, and described as follows:

Closure:

The portion of Evans Street (CR-195) at 135 Evans St. between Belmont Place to Eagle Street will have full road closure. This closure will begin on July 8 with an estimated completion date of July 19 or until complete. This closure will be between the hours of 7am to 4pm, daily. The road will be open to local traffic and emergency services. This closure is for the purpose of construction of utilities for the proposed Blocher Homes Apartments. Visone Co. Site Development LLC will be performing the work.

A closure is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
