WHEREAS, the Village of Williamsville has undertaken an update to the Community Plan established in 2010 and amended in 2015; and

WHEREAS, the Village Community Plan Update Project Charter has been prepared under the guidance and review of the Community Plan Steering Committee, with consultant planning services provided by the consultant firm of WWS Planning; and

NOW, THEREFORE, BE IT RESOLVED, that the Village Community Plan Update Project Charter is hereby adopted by the Village Board of Trustees.

WHEREAS, the South Cayuga Road Pedestrian Crosswalk Project was duly advertised, and bids for the project were opened at 10:00a.m. on Tuesday, April 16, 2024; and

WHEREAS, two (2) bids were received for the project;

NOW, THEREFORE, BE IT RESOLVED, that the Contract for the South Cayuga Road Pedestrian Crosswalk Project is hereby awarded to Occhino Corp., 2650 Seneca Street, West Seneca, New York for their low bid amount of \$219,550.00.
